Yes there were, civil society, private sector and various institutions in governance were invited.

Civil society was invited by Government into the Committee charged with the responsibility of writing the report. CSOs were involved at the early stage of report writing and participated through out the processes.

D. CSOs own implementation of the 2030 Agenda for Sustainable Development/SDGs

13. How far are CSOs developing their own plans on implementation of the agenda in your country?

These are needs improvement. Though the Nigeria Network of NGOs has trained over 200 civil society organisations on how to integrate the SDGs within their plans and programmes, we are yet to see publicly available written plans (strategic plans, work plans, implementation plans and budgets) that capture SDGs attainment on the part of CSOs in the country.

14. Are there particular case studies of effective delivery by CSOs already underway?

This is yet to be researched however there certainly will be.

15. Are there challenges to prevent CSO delivery of this agenda in your country?

Asides funding challenges, awareness of the SDGs amongst civil society is still weak, because the SDGs is also knowledge and evidence based, civil society will continue to be challenged in the areas of providing concrete evidence to support their work since data is a big missing link and documentation on the part of CSOs is also weak.

16. What is the engagement of other stakeholders like the private sector in the national implementation plan? Is there a broader partnership across sectors for implementation? Have any challenges or opportunities been identified in terms of broader partnerships?

Yes there are broader partnerships. The country has a private sector advisory group on the SDGs and a CSO advisory group. It is yet to be seen though how both groups can come together to work in partnership with government on the attainment of the goals



rather than in silos.

17. Is there any clear national plan in terms of funding the delivery of the 2030 Agenda?
